## Indian Youth Service Corps Opportunity



Following the York Fire which burned more than 8,000 acres within Avi Kwa Ame National Monument, an Emergency Stabilization and Rehabilitation Plan was developed to help stabilize and protect the burned area from further degradation. Through the Indian Youth Service Corps Program, the BLM would like to collaborate with eligible Tribal youth to implement stabilization and rehabilitation activities within the affected areas. Activities may include site monitoring, barrier construction, seeding and native species planting.

#### **Restoration Project on the Horizon**

Beginning in the second quarter, Clark County's Desert Conservation Program, in coordination with BLM, will implement restoration actions in the approved Piute-Eldorado Area of Critical Environmental Concern Management Plan with funding provided through the Southern Nevada Public Lands Management Act. The goal will be to restore, improve or enhance disturbed desert tortoise critical habitat and to minimize the potential of re-disturbance of the sites or creation of new sites. Restoration will focus on linear disturbances caused by unauthorized off-road vehicle use and within the Piute-Eldorado Valley Area of Critical Environmental Concern (almost entirely within Avi Kwa Ame National Monument.) This will include vertical mulching, native species planting and construction of barriers and fences.

### **PBS Outdoor Nevada**

Great news! A segment on Avi Kwa Ame National Monument will be featured on Vegas PBS's Outdoor Nevada show. A date has not been released yet, but the show airs on Wednesdays at 7:30 p.m. and is also posted on their website.

Jimmy Linares, former Interim Monument Manager for Avi Kwa Ame National Monument, talked about partnerships with the Tribes and National Park Service, how folks can enjoy the area safely, sights and animals they will likely see, his favorite spots, as well as the York Fire and how it impacted the monument. Lillian Setters, Las Vegas Field Office Natural Resources Specialist, discussed the wonders of the plants in Avi Kwa Ame National Monument and the Mojave Desert overall. Fort Mojave Indian Tribe also provided several spectacular interviews.
