The event featured Tribal veteran's posting of colors, Tribal band performance, special remarks and recognition by Vice Chair Shan Lewis, Tribal Council Secretary and Tribal Elder Collen Garcia, Director of the Aha Macav Cultural Center Linda Otero, as well as Tribal Royalty and finished with a bird dance and song performance. Other highlights included a framed and mounted Presidential Monument proclamation as well as delicious refreshments and Monument t-shirts, posters, magnets and stickers. In celebration for years to come, the Fort Mojave Indian Tribe has established March 21 as a holiday.
